**1. Assumption of Risk**

I acknowledge that this cycling event is a strenuous test of physical and mental limits and carries with it the potential for death, serious injury, and property loss. The risks include, but are not limited to:

- Terrain and road conditions (potholes, debris, uneven surfaces)
- Weather (heat, cold, rain, wind)
- Mechanical failures (bicycle or equipment malfunction)
- Collisions with vehicles, other riders, or stationary objects
- Actions of other people, including participants, volunteers, spectators, coaches, event officials, and event monitors
- Lack of hydration or nutrition

These risks are inherent to cycling and athletics. I understand that by participating, I am assuming these inherent risks. I further acknowledge that this release applies only to **ordinary negligence** of the Released Parties, and does not apply to **gross negligence, reckless conduct, or willful misconduct**, which cannot legally be waived in California.

**2. Physical Fitness Certification**

I certify that I am physically fit and able to safely participate in this event and have not been advised otherwise by a qualified medical professional.

**3. Use of Agreement**

I understand that this Waiver and Release of Liability (“Agreement”) will be relied upon by the Fremont Freewheelers Bicycle Club and all individuals and entities organizing, supporting, or involved with this event (collectively, the “Released Parties”). It will govern my actions and responsibilities before, during, and after the event.

**4. Release of Liability for Ordinary Negligence**

In consideration for being permitted to participate in this event, I hereby release and discharge the Released Parties from liability for ordinary negligence resulting in personal injury, death, or property damage arising out of or connected to my participation in this event. This release does not apply to claims based on gross negligence, reckless conduct, or willful misconduct.

**5. Indemnification**

I agree to indemnify and hold harmless the Released Parties from claims arising out of my own negligent or intentional acts during the event. This indemnification does not extend to claims arising from the Released Parties’ own negligence.

## 6. Medical Treatment Consent

I consent to receive medical treatment deemed advisable during the event. I understand that this does not create a duty for the Released Parties to provide such treatment.

## 7. Photography and Media Release

I understand that at this event or related activities, I may be photographed. I agree to allow my photo, video, or film likeness to be used for any legitimate purpose by the event holders, producers, sponsors, organizers, and/or assigns.

## 8. Severability and Governing Law

This Agreement shall be governed by California law. If any provision of this Agreement is determined to be unenforceable, all remaining provisions shall remain in full force and effect.

### **Minor Release – Parent/Guardian Consent and Acknowledgment (for participants under 18 years of age)**
